



Friends, new Life and Dependent Members have been inducted. A very warm welcome to them and their families to ours, and now theirs too "SECOND HOME."


COVID has taken away a few of our members and also loved ones of our members. Let us pray for their souls to rest in peace and give strength to the families to bear the tragic loss.

The Flag Hoisting Ceremony on 15th August witnessed a huge turnout which just goes on to show the patriotic spirit of our members.

The construction of the first phase of the Master Plan will be started this month. And revamping of system and operations are running at full throttle. We will be completing the project within the deadline. Your satisfaction is our goal.

I am also enclosing the list of Working Committee for the year 2021-23 for your kind information and with the request that in case of any difficulty please consult the concerned Ex-officio who will resolve it.

# *Implementation of* **MASTER PLAN**

The EGM approved the master plan of the Club in its meeting held on 20.05.2017. After this, the maps were got prepared and were submitted to Jaipur Nagar Nigam for its approval. Jaipur Nagar Nigam, vide its letter dated 10.01.2020, approved the maps for the construction and Jaipur Club has deposited the requisite fee amount of Rs. 20,32,562/-. After the approval of the maps by Jaipur Nagar Nigam, a walkthrough and a model was prepared as per the Management Committee's decision. The walkthrough was sent through e-mail to the club members and model is on display at club reception. We prepared the BOQ (Bill of quantity) for the first phase of the construction.

A tender for the first phase of construction as per the approved maps by Nagar Nigam was published in the leading newspapers i.e., Rajasthan Patrika, Dainik Bhaskar and Times of India on 01.04.2021. The last date of submission of tender document (RFP for expansion of Jaipur Club B-Block Building, Jaipur on item rate mode) was 23.06.2021 at 5:00 pm. We have received the 8 tenders within the time limit.

We formed a Techno-Commercial Bid Evaluation Committee alongwith present Management Committee Office Bearers who were authorized to process further the final tender document, BOQ submitted by Architect etc. also to negotiate and finalize the tender after receiving the BIDs.

The Master Plan Bid Evaluation Committee after going through all the technical and financial process and final negotiation, the Committee unanimously decided to award the work to the lowest tender to **M/s. Sanchar Infratech Private Limited.**

**We are pleased to inform you that due to negotiation, the Club had saved Rs. 31,49,414/- (Rupees Thirty One Lakhs Forty-Nine Thousand Four Hundred Fourteen) in the project cost.**

We thank all the Committee members for their untiring efforts and sparing valuable time from their busy schedule for finalizing the tender.

**The foundation stone laying ceremony will be held on Friday 10th September, 2021.**




