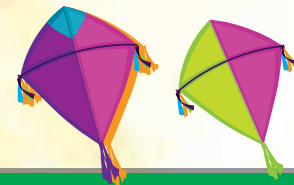

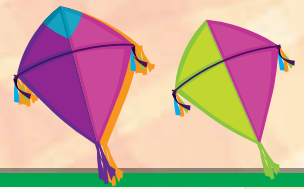


JCL BIOMETRIC IDENTITY CUM SMART CARD

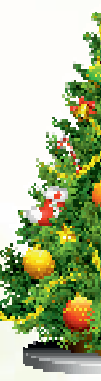

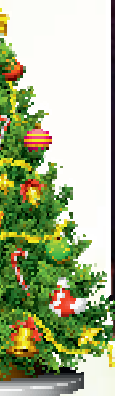

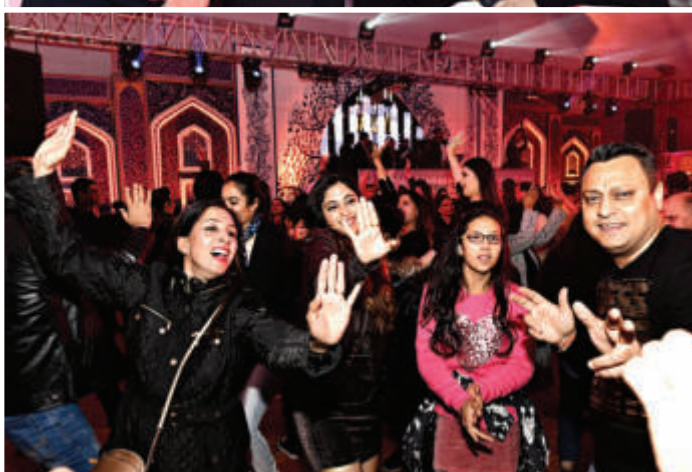
