- 2. Depreciation has been provided as per the rates provided in the Income Tax Rules, 1962 in the Books of Accounts, Value of Fixed Assets has been stated at WDV less Depreciation for the current year.
- 3. Method of valuation of closing stock is at cost or Net Market Value whichever is less.
- 4. All the income and expenses are generally recognized on accrual basis.
- 5. Previous years figures have been regrouped and rearranged wherever necessary to confirm to current years classification.
- 6. That the Current Assets and Advances are approximately the value situated if realized in the ordinary course of business timeless otherwise stated. Provisions for all liabilities are adequate and are not in excess/shortage of the amount reasonably necessary.
